**AMENDED ARTICLES OF  
INCORPORATION**

**ARTICLE I  
NAME**

The name of this corporation shall be Let's Support the Children. The nonprofit corporation may conduct as Let's Support the Children or Support the Children.

**ARTICLE II  
DURATION**

**2.01 Duration**

The period of duration of the corporation is perpetual.

**ARTICLE III  
PURPOSE**

**3.01 Purpose**

Let's Support the Children is a non-profit corporation and shall operate exclusively for educational and charitable purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future Federal tax code.

**Education and Community Development program –**

Let's Support the Children is dedicated to supporting education in all states and providences in the United States and its territories abroad. Let's Support the Children aids public schools by providing supplies and equipment needed by teachers and school faculty to accomplish educational goals. In addition, Let's Support the Children helps after-school and pre-kindergarten programs with necessities that reinforce subject areas in Arts, Math, Science, Sports, Literature, and History.

### **3.02 Non-Profit**

Let's Support the Children designated as a non-profit corporation.

## **ARTICLE IV NON-PROFIT NATURE**

### **4.01 Non-profit Nature**

Let's Support the Children is organized exclusively for charitable and educational purposes including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. No part of the net earnings of Let's Support the Children shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons. In exception Let's Support the Children shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes outlined in the purpose clause hereof.

Notwithstanding any other provision of this document, the corporation shall not carry on any other activities not permitted to be carried on (a) by any organization exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code. In the corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Let's Support the Children is not organized and shall not operate for the private gain of any person. The property of the corporation irrevocably focuses on its educational and charitable purposes. No portion of the assets, receipts, or net earnings of the corporation shall inure to the benefit of, or to distribute to any individual. The corporation may, however, pay reasonable compensation for services rendered, and make other payments and distributions consistent with these Articles.

### **4.02 Personal Liability**

No officer or director of this corporation shall be personally liable for the debts or obligations of Let's Support the Children of any nature whatsoever, nor shall any of the property or assets of the officers or directors be subject to the payment of the debts or obligations of this corporation.

### **4.03 Dissolution**

Upon termination or dissolution of the Let's Support the Children, any assets lawfully available for distribution distribute to one (1) or more qualifying organizations described in Section 501(c)(3) of the Internal Revenue Code of 1986. (or related in any corresponding provision of any successor statute) which organization or organizations have a charitable purpose which, at least generally, includes a use similar to the terminating or dissolving corporation

The organization to receive the assets of the Let's Support the Children hereunder shall select by the discretion of a majority of the managing body of the Let's Support for the Children. If its members cannot so agree, then the recipient organization shall be selected pursuant to a verified petition in equity filed in a court of proper jurisdiction against the Let's Support the Children by one (1) or more of its managing body which verified petition shall contain such statements as reasonably indicate the applicability of this section. The court upon a finding that this section is applicable shall select the qualifying organization or organizations to receive the assets to be distributed, giving preference if practicable to organizations located within the State of Nevada, according to NRS Chapter 82.

#### **4.04 Prohibited Distributions**

No part of the net earnings or properties of this corporation, on dissolution or otherwise, shall inure to the benefit of, or be distributable to, its members, directors, officers or other private person or individual. In exception, Let's Support the Children shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes outlined in Article III, Section 3.01.

#### **4.05 Restricted Activities**

No substantial part of the corporation's activities shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene (including the publishing or distribution of statements) in any political campaign on behalf of or in opposition to any candidate for public office.

#### **4.06 Prohibited Activities**

Let's Support the Children provision of these Articles, the corporation shall not carry on any activities not permitted to be carried on:

(I) by a corporation exempt from federal income tax as an organization described by Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or

(II) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

## **ARTICLE V** **BOARD OF DIRECTORS**

### **5.01 Governance**

Let's Support the Children, shall be governed by its board of directors.

### **6.01 Membership**

Let's Support the Children shall have no members. The management of the affairs of the corporation shall be vested in a board of directors, as defined in the corporation's bylaws.

Any amendment to the Articles of Incorporation may adopt by approval of two-thirds (2/3) of the board of directors.
